This PhD research intends to contribute to the literature through examining the economic performance of dollarised small emerging economies. The work will consist of three related topics on evaluating the impact of dollarisation on small emerging economies. Specifically, the following studies will be conducted: (1) Examine the performance of fully dollarised economies on real economy (output growth, investment levels, trade and net exports' growth; (2) Examine the performance of dollarised economies on financial indicators (inflation, credit growth, asset prices, reserve requirements); and (3) Meta-Regression analysis on dollarisation impact on GDP growth. The selected studies will be enriched by comparing the impact of dollarisation before and after the global financial crisis of 2008 as well as the COVID-19 pandemic crisis. The latter might provide important insights with regards to financing availability, in absence of monetary policy, of small emerging economies as a response mechanism towards crisis. Furthermore, comparative study on the economic performance between different exchange rate mechanisms, namely fully dollarised, partially dollarised and floating and fixed exchange rate regimes will be conducted. Timing of this research allows to observe a lengthier period of dollarisation experience compared to many available studies on the topic. Specifically, this PhD intends to study the economic performance of dollarised economies for over 20 years, starting from the year 2000, which should provide unbiased results, offsetting potential short-term economic fluctuations. To address the hypothesis in this research, panel and time series data will be utilised, using secondary data sources, primarily on the World Bank database, IMF, and other sources, such as domestic central banks' databases.
